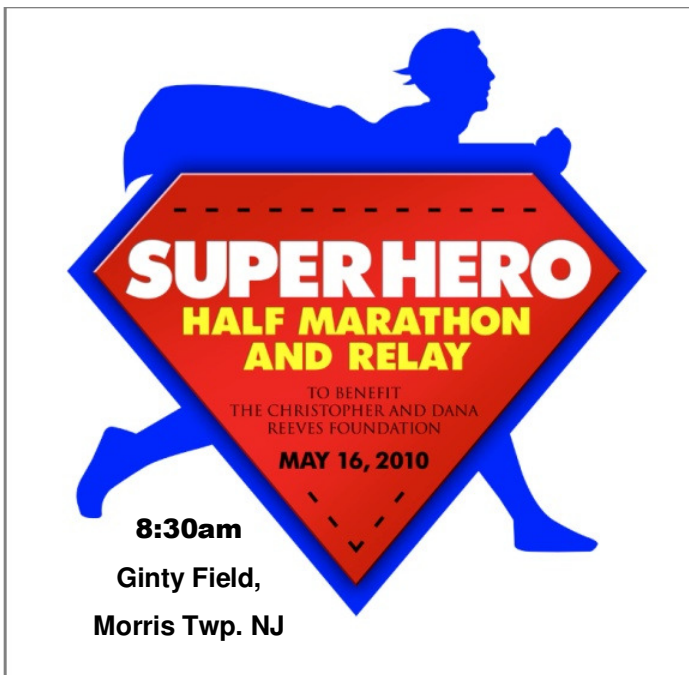

If coming from the North, take route 287 to exit 35. Follow the exit ramp to the right and then turn right onto South St. Proceed about 1 mile and The Morristown Running Company will be on your left just before the town Green.

Directions to race site: If coming from the North, take route 287 to exit 35. Follow exit ramp to the right onto Madison Ave. and then make a quick left at the light onto South Street. Proceed about 0.5 miles and then a left onto Woodland Avenue. Race site will be on the right.
